KLANJE STOKE I PERADI U 2018. SLAUGHTERING OF LIVESTOCK AND POULTRY, 2018

Prema raspoloživim podacima ukupnoga klanja stoke u klaonicama, u 2018. u usporedbi s 2017. broj zaklanih goveda ostao je na gotovo istoj razini.

Klanje svinja je u porastu za 3,3% odnosno zaklano je oko 32 900 grla više nego godinu prije. Broj ovaca zaklanih u klaonicama veći je za oko 7 100 grla odnosno 6,4%, dok je kod klanja peradi zabilježeno povećanje od 1,9%, odnosno oko 742 000 komada više nego godinu prije.

U pogledu neto težine stoke zaklane u klaonicama zabilježeno je povećanje proizvodnje kod goveda za oko 1 100 t (2,7%), svinja za oko 3 600 t (5,0%), dok je kod ovaca zabilježen rast za oko 78 t (6,1%). Neto težina peradi zaklane u klaonicama veća je za oko 1 700 t (2,6%).

Ukupno zaklana stoka i perad, koja uključuje i procjenu domaćega klanja na gospodarstvima, u usporedbi s prethodnom godinom bilježi sljedeća kretanja.

Broj zaklanih svinja veći je za oko 100 200 grla, što je povećanje od 6,8%, dok je neto težina zaklanih grla u porastu za 8,6%, odnosno oko 9 000 t.

Broj ukupno zaklanih ovaca veći je za oko 49 400 grla (12,2%) uz povećanje neto težine za 554 t (11,8%).

Kod ukupnog klanja koza bilježi se smanjenje broja za oko 8 700 grla, odnosno 16,8%, te neto težine za 104 t (15,8%).

Kod ukupno zaklane peradi smanjenje neto težine iznosi 3,6% (2 900 t) i broja za oko 837 700 komada (1,8%).

Podaci o ukupnom klanju goveda jednaki su podacima klanja goveda u klaonicama.

U vezi s bruto domaćom proizvodnjom situacija je slijedeća.

Izraženo u postocima, broj zaklanih goveda povećan je za 25,9% a težina za 16,7%. Također je povećan broj ukupno zaklanih ovaca (za 2,7%) te njihova neto težina (za 2,8%).

Broj ukupno zaklanih svinja povećan je za 8,2%, dok je neto težina veća za 9,7%. Kod koza broj zaklanih grla manji je za 16,8%, dok je neto težina manja za 15,8%.

Brojčano to iznosi oko 19 900 grla više zaklanih goveda, 9 600 ovaca, te oko 103 200 grla više zaklanih svinja odnosno 8 700 manje zaklanih koza. U pogledu neto težine povećanje kod goveda iznosi 6 100 t, ovaca 116 t, svinja 11 400 t, dok je kod koza neto težina manja za 104 t.

Broj peradi smanjen je za 0,8% (396 700 komada), a neto težina za 2,8% (2 300 t).

According to available data on the total slaughter of livestock in slaughterhouses, the number of slaughtered cattle remained almost the same in 2018 compared to 2017.

The slaughter of pigs increased by 3.3%, that is, approximately 32 900 head more were slaughtered than in the previous year. The number of sheep slaughtered in slaughterhouses rose by approximately 7 100 head, that is, 6.4%, while the slaughter of poultry increased by 1.9%, that is, approximately 742 000 head more were slaughtered compared to the previous year.

Concerning the net weight of livestock slaughtered in slaughterhouses, an increase of approximately 1 100 t (2.7%) was recorded in the production of cattle and of 3 600 t (5.0%) in the production of pigs, while the production of sheep increased by approximately 78 t (6.1%). The net weight of poultry slaughtered in slaughterhouses increased by approximately 1 700 t (2.6%).

Concerning total slaughtered livestock and poultry, including also the estimate of domestic slaughtering on private family farms, the following changes were recorded compared to the previous year.

The number of slaughtered pigs increased by approximately 100 200 head, i.e. by 6.8%, while the net weight of slaughtered pigs increased by 8.6% (about 9 000 t).

The total number of slaughtered sheep increased by approximately 49 400 head (12.2%), while the net weight increased by 554 t (11.8%).

The total number of slaughtered goats decreased by approximately 8 700 head, i.e. 16.8%, and the net weight by 104 t (15.8%).

A decrease in the net weight of total slaughtered poultry amounted to 3.6% (2 900 t) and in their number to approximately 837 700 head (1.8%).

The data on the total slaughtered cattle equal those on the cattle slaughtered in slaughterhouses.

Concerning the gross indigenous production, the situation was as follows.

Expressed in percentages, the number of slaughtered cattle increased by 25.9% and the net weight by 16.7%. An increase was also recorded in the number of total slaughtered sheep (by 2.7%) and in their net weight (by 2.8%).

The total number of slaughtered pigs increased by 8.2% and their net weight by 9.7%. Regarding goats, the number of slaughtered head decreased by 16.8% and their net weight by 15.8%.

Presented in numbers, there were approximately 19 900 head more of slaughtered cattle, 9 600 of slaughtered sheep and about 103 200 of slaughtered pigs, while there were 8 700 head less of slaughtered goats. Concerning the net weight, the increase amounted to 6 100 t in the category of cattle, 116 t in the category of sheep and 11 400 t in the category of pigs, while it decreased by 104 t in the category of goats.

The number of slaughtered poultry decreased by 0.8% (396 700 head) and their net weight by 2.8% (2 300 t).





METODOLOŠKA OBJAŠNJENJA

Izvor i metode prikupljanja podataka

Godišnji podaci o klanju stoke i peradi u klaonicama preuzimaju se od Ministarstva poljoprivrede – Službe za kontrolu sustava razvrstavanja govedih, svinjskih i ovčjih trupova.

Podaci ukupnoga godišnjega klanja stoke i peradi dobiveni su, osim iz administrativnih podataka o klanju stoke i peradi u klaonicama, i na temelju podataka prikupljenim redovitim godišnjim istraživanjima broja stoke i stočne proizvodnje kod poslovnih subjekata i na obiteljskim poljoprivrednim gospodarstvima.

Podaci o uvozu i izvozu stoke i peradi preuzimaju se iz statistike robne razmjene s inozemstvom.

Istraživanjem klanja stoke i peradi u klaonicama prikupljaju se podaci o broju zaklane stoke po vrstama i kategorijama, njihovoj težini prije klanja (bruto težina), težini obrađenog trupa (neto težina) te podaci o randmanima.

Podaci o broju zaklane stoke i peradi na gospodarstvima i prisilnom klanju kod pravnih osoba prikupljaju se, među ostalim, iz podataka o bilancima stoke i peradi.

Metodologija za provedbu istraživanja o stočarstvu temelji se na Uredbi (EZ) br. 1165/2008 Europskog parlamenta i Vijeća o statističkim podacima o stočarstvu i mesu od 19. studenoga 2008.

Obuhvat i usporedivost

Izvještajne jedinice za koje se podnose mjesечni izvještaji o klanju stoke i peradi jesu pravne osobe i njihovi dijelovi te obrtnici koji se bave djelatnošću klanja stoke i peradi.

Podaci o broju stoke i stočnoj proizvodnji za poslovne subjekte prikupljaju se na dva načina: izvještajima koji se poštom dostavljaju Državnom zavodu za statistiku i u internetskoj aplikaciji koju izvještajne jedinice ispunjavaju same.

Podaci za obiteljska poljoprivredna gospodarstva prikupljeni su metodom telefonskog anketiranja na odabranome stratificiranim uzorku. Uzorak je izabran iz Statističkog registra poljoprivrednih gospodarstava kao baze, a ima oko 10 000 jedinica.

Prognoza bruto domaće proizvodnje temelji se na modelima procjene korištenjem podataka iz raspoloživih administrativnih izvora i redovitih statističkih istraživanja.

NOTES ON METHODOLOGY

Sources and methods of data collection

Annual data on slaughtering of livestock and poultry in slaughterhouses are taken over from the Ministry of Agriculture – Department for the Control of the Carcass Classification System for Cattle, Pigs and Sheep.

Data on the total annual slaughtering of livestock and poultry are also obtained, except from administrative data on the slaughtering of livestock and poultry in slaughterhouses, on the basis of data collected in regular annual surveys on the number of livestock and livestock production at business entities and on private family farms.

Data on export and import of livestock and poultry are taken over from the external trade in goods statistics.

This survey serves for collecting data on the number of slaughtered livestock by types and categories, their weight before slaughtering (gross weight), the weight of dressed carcass (net weight) and data on coefficients of utilisation.

Data on the balance of livestock and poultry also include information on the number of slaughtered livestock on private family farms as well as on compulsory slaughtering at legal entities.

The methodology for carrying out the livestock survey is based on the Regulation (EC) No. 1165/2008 of the European Parliament and of the Council of 19 November 2008 concerning livestock and meat statistics.

Coverage and comparability

Reporting units that submit monthly reports on livestock and poultry slaughtering are legal entities, parts thereof and tradesmen engaged in the activity of livestock and poultry slaughtering.

Data on the number and production of livestock for business entities are collected in two ways: on reports submitted to the Croatian Bureau of Statistics by postal service and by using the internet application filled in by reporting units themselves.

Data for private family farms are collected by telephone interviewing on a selected stratified sample. The sample has been selected from the Statistical Register of Agricultural Holdings, which has approximately 10 000 units.

Gross indigenous production forecast is based on estimation models by using data from available administrative sources and regular statistical surveys.

Povjerljivost

Agregirani podaci kod kojih postoje razlozi za povjerljivost (zbog malog broja jedinica, pravila dominantnosti ili sekundarne povjerljivosti), u skladu sa Zakonom o službenoj statistici (NN, br. 103/03., 75/09., 59/12. i 12/13. – pročišćeni tekst) i Pravilnikom o načinu zaštite statističkih podataka Državnog zavoda za statistiku, tretiraju se kao povjerljivi te se stoga ne objavljaju.

Definicije

Neto težina jest težina očišćenog trupa, zaklane stoke i peradi bez kože, krvi, glave (osim kod odojaka i peradi), utrobe, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba.

Randman zaklane stoke i peradi jest postotni odnos težine zaklane stoke i peradi (neto težina) i težine žive stoke i peradi (bruto težina), a iskazuje se u postocima.

Ukupno klanje stoke i peradi obuhvaća svu stoku i perad zaklanu na području Republike Hrvatske bez obzira na podrijetlo. To je zbroj klanja stoke i peradi u klaonicama i klanja stoke i peradi kod pravnih osoba (prisilno klanje) te na obiteljskim poljoprivrednim gospodarstvima. Podaci ukupnog klanja goveda obuhvaćaju isključivo goveda zaklana u klaonicama.

Bruto domaća proizvodnja obuhvaća stoku i perad uzgojenu na području Republike Hrvatske. To je razlika ukupno zaklane stoke i peradi i vanjskotrgovinske bilance (bruto domaća proizvodnja = ukupno klanje stoke i peradi – u meso preračunana masa živih uvezenih životinja + u meso preračunana masa živih izvezenih životinja).

Prognoza bruto domaće proizvodnje odgovara ocjeni broja zaklanih goveda, svinja i ovaca i vanjskotrgovinske bilance živih životinja.

Confidentiality

Aggregated data for which there are reasons for confidentiality (small number of units, the dominance rule or secondary confidentiality rule) according to the Official Statistics Act (NN, Nos 103/03, 75/09, 59/12 and 12/13 – consolidated text) and to the Ordinance on the Statistical Data Protection Method are treated as confidential and therefore are not published.

Definitions

Net weight is the weight of dressed carcass of slaughtered animals without skin and blood, eviscerated and beheaded (not including piglets and poultry), and after removal of the viscera, fore ends and hind legs with knuckle.

Coefficient of utilisation of slaughtered livestock and poultry is a percentage ratio of the weight of the slaughtered cattle and poultry (net weight) and the weight of livestock and live poultry (gross weight), and it is presented in percentage.

Total slaughtering of livestock and poultry covers all livestock and poultry slaughtered on the territory of the Republic of Croatia, irrespective of origin. It represents the sum of livestock and poultry slaughtered in slaughterhouses and livestock and poultry slaughtered at legal entities (compulsory slaughtering) and on private family farms. The data on the total slaughtering of cattle include solely the cattle slaughtered in slaughterhouses.

Gross indigenous production covers livestock and poultry bred on the territory of the Republic of Croatia. It represents the difference between the total slaughtered livestock and poultry and the external trade balance (gross indigenous production – slaughtered meat production minus the meat equivalent of animals imported alive plus the meat equivalent of animal exported alive).

Gross indigenous production forecast corresponds to the estimate of slaughtered cattle, pigs and sheep plus their external trade balance.
