

**PROMET U ZRAČNIM LUKAMA
U TRAVNJU 2020.**

**TRAFFIC IN AIRPORTS
APRIL 2020**

U travnju 2020. hrvatske zračne luke zabilježile su 4 482 putnika ili 99,4% manje nego u istome mjesecu prošle godine, kada je ostvaren promet od 755 657 putnika.

The total traffic of passengers in airports amounted to 4 482 in April 2020, which was 99.4% less than in April 2019, when the total traffic of passengers amounted to 755 657.

Okolnosti prouzročene širenjem bolesti COVID-19 izravno su utjecale na pad prometa putnika u hrvatskim zračnim lukama ukidanjem linija i zatvaranjem zračnih luka za civilni promet putnika.

The circumstances brought about by the COVID-19 pandemic have directly influenced the decrease in the traffic of passengers in Croatian airports by cancelling lines and closing airports for civilian passenger traffic.

Gotovo sav promet putnika (4 478) ostvarila je Zračna luka Zagreb (pad od 98,4% u odnosu na travanj 2019., kada je u toj zračnoj luci ostvaren promet od 279 230 putnika).

Almost all passenger traffic (4 478) was recorded at the Zagreb Airport (a decrease of 98.4% compared to April 2019, when the traffic of passengers amounted to 279 230).

Najznatniji međunarodni putnički promet ostvaren je sa zračnim lukama Njemačke, 3 467 putnika, što je pad od 98,3% u odnosu na isto razdoblje prošle godine.

The most significant international traffic was realised with German airports, 3 467 passengers, which was a decrease of 98.3% compared to the same period in the previous year.

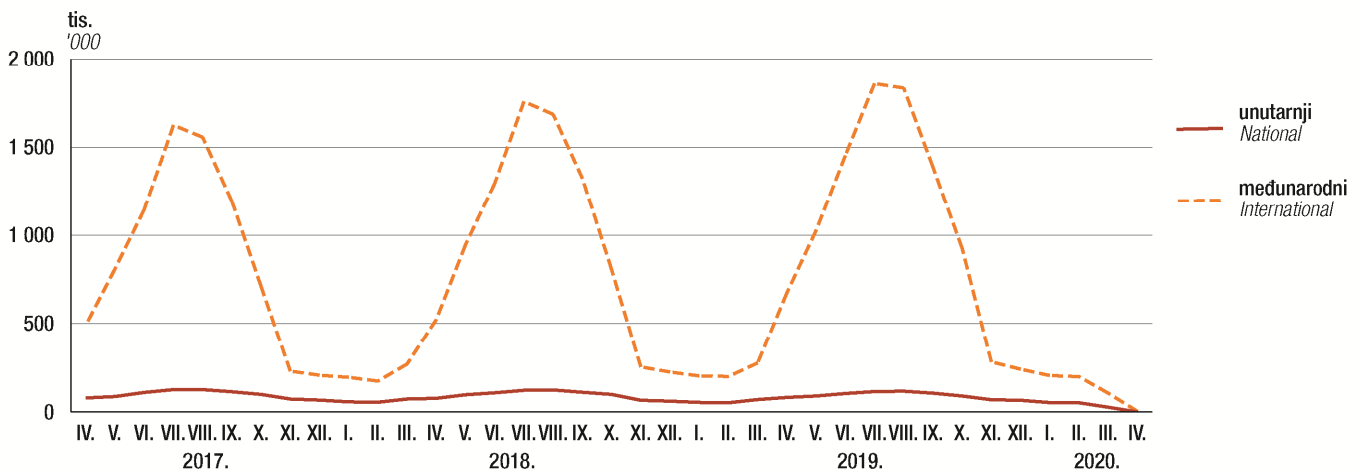
Ukupan broj slijetanja i polijetanja zrakoplova u zračnim lukama u travnju 2020. iznosio je 420, što je u usporedbi s travnjem 2019. pad od 95,4%.

The total number of landings and take-offs in airports in April 2020 amounted to 420 movements, which was 95.4% less than in April 2019.

Ukupan promet tereta u zračnim lukama u travnju 2020. iznosio je 797 tona, što je u usporedbi s travnjem 2019. pad od 26,6%.

The total traffic of freight in airports in April 2020 amounted to 797 tonnes, which was a decrease of 26.6% compared to April 2019.

METODOLOŠKA OBJAŠNJENJA

Izvori i metode prikupljanja podataka

Kumulativni podatak nije uvijek jednak zbroju pojedinačnih mjesečnih rezultata zbog zaokruživanja na tisuće.

Svrha istraživanja jest prikupiti podatke o broju svih operacija zrakoplova, prometu putnika i tereta na komercijalnim operacijama u zračnim lukama te u pristaništima Republike Hrvatske.

Jedinice promatranja i izvještajne jedinice jesu zračne luke u Republici Hrvatskoj. Podaci su prikupljeni u obliku elektroničkih setova i na obrascu PZ/M-21.

Obuhvat

Podaci o zračnom prometu (ukupne operacije zrakoplova, promet putnika i tereta u zračnim lukama) odnose se na rad zračnih luka Zagreb, Split, Dubrovnik, Pula, Rijeka, Zadar, Osijek, Brač te zračnog pristaništa Mali Lošinj.

NOTES ON METHODOLOGY

Sources and methods of data collection

Cumulative data are not always equal to the sum of individual monthly results due to the rounding of numbers to the nearest thousand.

The purpose of the survey is to collect data on the number of all aircraft movements and the traffic of passengers and freight on commercial operations in airports and air landing places of the Republic of Croatia.

The observation units and reporting units are airports in the Republic of Croatia. Data are collected in the form of electronic datasets and on the PZ/M-21 form.

Coverage

The data on air traffic (total aircraft movements, traffic of passengers and freight in airports) relate to the activities of the airports of Zagreb, Split, Dubrovnik, Pula, Rijeka, Zadar, Osijek, Brač and the air landing place of Mali Lošinj.

Broj ukupnih operacija zrakoplova u zračnim lukama odnosi se na broj svih (komercijalnih i nekomercijalnih) operacija slijetanja i polijetanja zrakoplova, osim državnih letova (vojska, carina, policija).

Promet putnika u zračnim lukama obuhvaća broj otputovalih i doputovalih putnika na komercijalnim operacijama. Isključeni su putnici u direktnom tranzitu. Putnici u direktnom tranzitu jesu putnici koji, nakon kratkog zaustavljanja, nastavljaju svoje putovanje istim zrakoplovom na letu s istim brojem leta kao let s kojega su stigli.

Promet tereta u zračnim lukama odnosi se na utovarenu i istovarenu robu i poštu na komercijalnim operacijama, osim prtljage putnika. Isključen je teret u direktnom tranzitu.

The number of total aircraft movements in airports refers to the number of all (commercial and non-commercial) operations of landing and taking-off of an aircraft, except state flights (military, customs, police).

Traffic of passengers in airports includes the number of passengers who have departed or arrived on commercial operations. Passengers in direct transit are excluded. Direct transit passengers are passengers who, after a short stop, continue their journey on the same aircraft on a flight having the same flight number as the flight on which they arrived.

Traffic of freight in airports refers to the loaded and unloaded goods and mail on commercial operations other than the baggage of passengers. The freight in direct transit is excluded.
